#### 2024-2025 CHILD LURES PREVENTION

Dear Parents/Guardians:

We have been asked, by the Diocese to provide a program that raises children's awareness to help them strengthen their own personal safety strategies. This program is called Child Lures Prevention. Teachers in St. Nicholas have been given lessons in the Child Lures Prevention program.

Some areas that will be discussed deal with the following and have been devised to enhance what you teach your own child at home.

Children should not speak with strangers or go anywhere with a stranger.

Children must ask permission, from a parent, if they are invited anywhere.

Parents should tell children, "If my Mom/Dad wouldn't like this, then I cannot do it".

Children should be made aware that they can be lured by people who sometimes have important positions or who are famous.

Children should be taught to respect their bodies.

Children should be taught not to help someone looking for a lost pet or help someone find a building address.

Children should be taught that they could be attracted by the promise of a modeling job, the chance to star in a commercial or have a spot in a talent or beauty contest or be given an athletic scholarship. Tryouts should only be taken with a parent present.

Children should be taught to never accept candy or toys.

Children should be taught that On-line communication opportunities are to be made with only those people that parents know.

A child's name, address and other personal information should never be given on line.

These topics will be discussed with your child so that preventive measures will be highlighted for their safety.

- Technology will be used to support learning and enhance instruction in a responsible, efficient, ethical, legal manner consistent with the moral teachings of the Roman Catholic Church
- Personal electronic devices when in school will be used for appropriate learning purposes

The academy reserves the right to monitor both student and employee use of technology and computer accessed content. Due to the evolving nature of technology, the academy reserves the right to amend or add to this policy at any time without notice.

All inappropriate references to academy personnel, students and/or any member of the academy community in any means such as but not limited to Facebook, Twitter, YouTube, Tumblr, Instragram, Google, web pages or email which is deemed by the principal to be injurious to the moral tone of the academy are violations of this policy.

Personal communication outside the scope of the educational mission of the academy is strictly forbidden.

Vandalism, any malicious attempt to damage and/or destroy hardware or software systems or the information of any other user, is strictly forbidden. This includes, but is not limited to, the creation, distribution, or proliferation of malicious software. If academy equipment is damaged in the course of these actions by an individual whether on or off campus, that individual assumes all responsibility for any and all damages and associated costs.

In accordance with New York State Law on Cyberbullying, inappropriate, defamatory or content found to be injurious to an academy community member may result in disciplinary action, even

if done outside of academy premises or using devices not owned or controlled by the academy. All instances of such behavior should be reported to the academy which will conduct an investigation to the best of its ability and enforce consequences deemed appropriate.
